Admission Procedure to FTZ for Bachelor's and Master's Levels of Education in Academic Year 2024/2025 – Opening of the Additional Stage of the Admission Procedure

Article 1

Study Programmes in the Supplementary Stage of the Admission Procedure

With this decree, the Dean of the Faculty of Tropical AgriSciences opens an additional stage of the admission procedure for the following Bachelor's programmes

- **Tropical Agriculture (TZ)**
- **International Cooperation in Agriculture and Rural Development (ICARD)**

and Master's Programs

- **Tropical Agroecology (TAE)**
- **International Development and Agricultural Economics (IDAE)**

due to their failure to fill their capacity in the regular admission procedure.

General rules for the admission procedure remain valid on the basis of the Dean's Regulation No. 3/2023 Admission Procedure to the FTZ for Bachelor's and Master's levels of education in the academic year 2024/2025.

Personal attendance of the applicant is required at all entrance examinations. Video interviews for applicants abroad in the additional stage in addition to the TAE programme are no longer possible.

Article 2

Dates of the Additional Stage of the Admission Procedure

Application Deadlines

- Submission of applications for study – 15/06/2024 - 15/07/2024

Deadlines for the delivery of certificates for admission without an admission procedure

- Additional stage for the PR programme: 15/07/2024
- Additional phase for the ICARD programme: 15/07/2024

Dates of the entrance examination – study programme TZ

- regular date (personal participation of the applicant) – in the week of 19/08/2024 - 23/08/2024
- alternative date (personal participation of the applicant) – 29/08/2024

Dates of the Entrance Examination – ICARD Study Programme

- 1st round – date of the online test – 23/07/2024 11:00 (CEST)
- 1st round – check of study prerequisites (without the applicant's participation) – 31/07/2024 - 04/08/2024
- 2nd round – date of the entrance examination (personal participation of the applicant) - in the week of 19/08/2024 - 23/08/2024
- 2nd round – alternative date (personal participation of the applicant) – 29/08/2024

Dates of the entrance examination – study programme TAE and IDAE

- 1st round – date of the online test – 23/07/2024 11:00 (CEST) (for IDAE program)
- 1st round – check of study prerequisites (without the participation of the applicant) – 24/07/2024 – 26/07/2024 (for the IDAE programme)
- Date of the admission interview (personal participation of the applicant) – 03/09/2024

Enrolment in studies (personal attendance of the student is required)

- Alternative date of enrolment in the PR programme: 10/09/2024
- Alternative date of enrolment in the ICARD programme: 17/09/2024
- Alternative date of enrolment in the TAE programme: 17/09/2024
