

# **CALL FOR ABSTRACTS**

The Organising and Scientific Committee are delighted to invite you to the **22nd European Roundtable on Sustainable Consumption and Production (ERSCP 2025)**. The event will focus on "**Multi-stakeholder cooperation on sustainability: Role of business, academia, public sector, and civil society in Sustainable Consumption and Production (SCP)**" with key topics listed below. It aims to present cutting-edge approaches in sustainability, environmental protection, and low-carbon economy, fostering collaboration among diverse sectors and will be accessible both on-site and online.

The conference will be held from **September 16-18, 2025, at the Czech University of Life Sciences, Prague** with the PhD Day organized September 15.

#### **SUBMISSION GUIDELINES**

**Abstracts**: Prospective authors are invited to submit abstracts of up to 500 words. Each submission must include a comprehensive title, the names and affiliations of all authors, and a clear description of the study's methods and expected conclusions. Abstracts must adhere to the provided template, which can be downloaded from the conference <u>website</u>. Please read the instructions carefully; the abstracts which do not adhere to these requirements and format will not be accepted and returned for resubmittal (always within the given deadline). Please carefully proofread the abstract before submission, and if necessary, have it proofread by a native English speaker.

#### **SUBMISSION PROCESS**

- Call opens January 1, 2025
- Create your account on the <u>conference submission platform</u>.
- Submit your abstract by **April 21, 2025** (2<sup>nd</sup> round).
- Communication of final decision: Latest May 1, 2025

### **CONFERENCE FORMATS**

- **Oral Presentations**: Oral presentations in 15-minute format followed by questions and discussion.
- **Thematic Sessions**: Thematic discussions, project presentations, panels, or workshops. Proposals should propose a coherent themed session lasting up to 90 minutes.
- **Poster Sessions**: Visual presentations displayed throughout the conference.
