

## Admissions to the FTZ for Bachelor's and Master's Degrees Academic Year 2025/2026 - Opening of the Additional Stage of Admissions

---

### Article 1

#### **Study programmes in the additional stage of the admission procedure**

By this order, the Dean of the Faculty of Tropical AgriSciences (FTZ) opens an additional stage of the admission procedure for the following Bachelor programmes

- **Tropical Agriculture (TZ)**
- **International Cooperation in Agriculture and Rural Development (ICARD)**

and Master's programmes

- **Agri-food Systems and Rural Development (ASRD)**
- **Wildlife and Livestock Production, Management and Conservation (WLPMC)**
- **Tropical Crop Management and Ecology (TCME)**
- **International Development and Agricultural Economics (IDAE)**
- **Tropical Forestry and Agroforestry (TFA)**
- **Tropical Farming Systems (TFS) - double degree form**
- **Tropical Agroecology (TAE) - online distance learning**

due to their capacity not being filled in the regular admission procedure.

### Article 2

#### **Course of the entrance examination for study programmes ICARD, ASRD, WLPMC, IDAE, TCME, TFA, TFS, TAE**

The general rules for the admission procedure remain in force on the basis of the Dean's Regulation No. 6/2024 Admission Procedure at the FTZ for Bachelor's and Master's Degrees for the academic year 2025/2026.

This regulation modifies the assessment criterion "General Overview", where the Scio GAP test is replaced by an online test in English. A candidate who, by July 15, demonstrates a Scio GAP test score from 2024 or 2025 is not required to take the online test.

The personal attendance of the applicant is required at all entrance examinations. Video interviews are no longer possible for applicants abroad in the additional stage except for the TAE programme.

### Article 3

#### **Dates of the additional stage of the admission procedure**

##### **Application deadlines**

- submission of applications for studies - 15 June 2025 - 15 July 2025

**Deadlines for the delivery of certificates for admission without an admission procedure**

- Additional stage for the TS programme: 15/07/2025
- Additional phase for ICARD: 15/07/2025

**Entrance examination dates - study programme TZ**

- regular term (personal participation of the candidate) - in the week of 25 August - 29 August 2025
- alternative date (personal participation of the candidate) - 2 September 2025

**Entrance examination dates - ICARD study programme**

- Round 1 - online test date - 23/07/2025 11:00 (CEST)
- Round 1 - check of study prerequisites (without the participation of the applicant) - 4 August - 8 August 2025
- Round 2 - date of the entrance examination (personal participation of the candidate) - in the week of 1 September - 5 September 2025

**Dates of the entrance examination - study programme ASRD,WLPMC, IDAE, TCME, TFA, TFS, TAE**

- Round 1 - online test – 23/07/2025 11:00 (CEST)
- Round 1 - check of study prerequisites (without the participation of the applicant) - 4 August - 8 August 2025
- Round 2 - date of the interview (personal participation of the applicant) - in the week of 1 September - 5 September 2025

**Enrolment (personal attendance of the student is required)**

- Alternative deadline for enrolment in the TZ programme: 9 September 2025
- Alternative date of enrolment in the ICARD programme: 16 September 2025
- Alternative date of enrolment in the ASRD,WLPMC, IDAE, TCME, TFA, TFS, TAE programme: 16 September 2025
